Submission Content

Executive Summary:

I am a B4 School Public Health Nurse and have worked in this role for the last 4 years. I believe that a very important change that needs to be brought in for 4 year olds across New Zealand is for all preschools to provide compulsory basic teaching .Sadly at this stage, the Ministry of Education are encouraging preschools to NOT do any teaching but just let them learn through play. Play of course is important, but I have yet to meet a 4 year old who doesn't like learning the basic early facts required for school. Children at this age appear to be 'hungry' to learn. They have an incredible capacity to learn, and I love to see their eyes light up when I talk to them about numbers, shapes, colours etc, and do some simple writing with them at the B4 checks. I see a lot of children whose parents work full -time, and the children are at preschool or daycare, and they are not being taught any basic facts by anyone. I have talked to new-entrant teachers who say that the children who have not learnt anything before starting school are at a real disadvantage, compared to the chidren who have learnt the foundations of numbers and reading etc. Quite a lot of preschools that I work with do spend ½ an hour a day doing a learning session with the 4 year olds, and I have watched groups of these 4 year olds thoroughly enjoying learning lots of interesting things. I have also spoken to parents who come from other countries where there is some formal teaching done with 4 year olds in the preschools and these children have learnt an incredible amount of information, because I strongly believe that almost all 4 year old's brains are very ready to learn an amazing amount of things, and that they normally thoroughly enjoy learning. I have a real concern for many of our 4 year olds that their brains are not being fed with information that they are more than ready to learn, which can then be built on when they get to school. For some of these children they start school with no understanding of basic facts, that they could have easly learnt if they had been taught, which then puts them on the back-foot as they start school, and they have to be put in a group that has to be taught information they could have learnt a year earlier, while other children are able to build on the information they have learnt before school, and therefore move ahead academically, just because people have spent time with them teaching them the basic facts.

Our children's brains are hungry to learn and be expanded just as their growing bodies are hungry for good nutrition. Please review the lack of teaching for our 4 year olds, and consider changing the NZ education policy so that all preschools provide basic tecahing for our amazing 4 year olds.
