Submission Content

9(2)(a)

I have knowledge of the dangers our children and wider society are facing in our present living circumstances. I fully support the papers that have been sent to you on this subject

It is common knowledge that our present health system is “in collapse” and that mainstream medicine is not coping with the deluge of ill health. Pharmaceuticals just do not heal. This model is broken and i advocate that “natural medicine” used for centuries be allowed and fully funded for those who wish to use it via integrative doctors, natural health practitioners, oosteopaths, chiropracters etc. We will be actually saving money adopting these modalities. Let the cannabis plant be grown for healing everything and for pain relief as it has meant to do rather than being suppressed.

What contributes to our ill health is what is in our water which is a “toxic pesticide soup” according to the Late Penny Bright (of Auckland). To retain our reliable and “safe” copperwire telecommunications network. As with the Christchurch earthquake the cell towers became useless. Copperwire landlines are able to work without power so why on earth are we allowing telecommunications companies to remove and cut this vital network because they wish to make money from cellular networks?? My father had his copperwire cut this week and he has hearing loss and we could not communicate effectively on his remaining intermittent phone relying on who knows what technology????!! This is taking our country “backwards”!

Smart meters have been widely used to replace safe analogue meters. Many people have been ill-informed of the negative health effects, cyber security issues and fire issues of smart meters. We are literally “swimming” in our own homes with electromagnetic fields (EMF’s) caused by smart meters and celltowers in our neighbourhoods – “hidden” dangerous health hazards- another cause of our cancer epidemic. Safe analogue meters need to be used instead.

Geoengineering pollution of our skies by many aircraft needs to cease. Many people in NZ have proof that this is occurring via rainwater tests that we have barium, strontium and aluminium present. 9(2)(a) Regional Council are “willfully blind” and refuse to do their own testing after presenting my evidence of the 3 substances above in 2015 and 2018. Regional council’s should not exist if they prove to be ineffective. Any increase in health statistics on breathing/asthma, heart problems etc. over the last few years would be a telltale sign.

The exponential increase in vaccine injury and death is becoming very concerning and along with that there is often parents of children not given fully informed consent. It has come to my attention that since 2004 every baby born in this country is automatically put on the vaccine schedule list unless parents “opt off” by signing a Ministry of Health form. I am concerned that there are not many parents at all who are informed of this. I have had multiple reports of parents (often on their own at home) who are visited by two vaccinating health professionals and are coerced into vaccinating their newborn babies and/or children. It is common practice in this country for the vaccine inserts to be discarded without the receiver of the vaccine/or parent of a child/ren given the opportunity to read the ingredients and know what possible health effects there are.

I strongly objected a few years ago when the Ministry of Health/District Health Boards decided that they were aiming to vaccinate 95% of our children. There are many such as my now 21 year old son who should never have received a vaccine because they are incompatible with the toxins within. We have paid dearly as a family for natural health remedies over the years (not subsidised by government) and therapies not available in the mainstream health system. My son has suffered over the years with food intolerances, eczema, “foggy brain” affecting his ability to function at school and socially. New Zealand should not follow the mandatory vaccine programme that the USA & Australian regimes

have inflicted on their children which has caused an outcry in their countries. There is an epidemic of vaccine injury and death in these countries which is reflected here in NZ.

I strongly object to the psychological profiling of youngsters entering school which often leads to mis-diagnosing of mental illness such as ADHD and ADD and GP's dishing out the drug Ritalin (otherwise known as Kiddie Cocaine). This often leads to drug addiction as an adult. 9(2)(a) Special Needs teacher has often approached government on the Ritalin issue saying there is absolutely no need for it at all. The child's diet needs sorting – no additives, artificial colouring etc. She travelled to Cuba more than 10 years ago to establish why Cuba had no children at all on Ritalin. It turned out that they eat organic food, have no fast foods, no junk food/additives in food. 9(2)(a) has largely been ignored by government which i find appalling.

Government should have worked out by now that our suicide rate is directly attributed to psychiatric drugs which do not work. The Health Minister has been gifted a book called "Anatomy of An Epidemic" written by Robert Whitaker who proves that with the use of psychiatric drugs over 50 years they have not worked but instead caused such illness and suffering to thousands of pharmaceutical addicts. What is needed are more counsellors, nutritionists, natural therapies to detoxify the body and to adopt the "Open Dialogue" programme to address psychological distress.

When these issues above are addressed our children and childrens children may have a chance of life on this beautiful island in the Pacific. My question to this government is, are you going to be brave enough to implement anything I have mentioned above to save the lives of your children and indeed yourselves and the people of Aotearoa?
