Research to assist you:

- Prenatal fluoride exposure and cognitive outcomes in children at 4 and 6-12 years of age in Mexico
- Prenatal fluoride exposure and attention deficit hyperactivity disorder (ADHD) symptoms in children at 6-12 years of age in Mexico city
- Fluoride exposure and thyroid function among adults living in Canada: Effect
 modification by iodine status
- <u>Community water fluoridation and urinary fluoride concentrations in a national</u> <u>sample of pregnant women in Canada</u>

As a dentist I am seeing more damage to teeth because of fluorosis in younger children. We must not allow children to be given this toxic substance and we should stop all future water fluoridation.

Rather direct fluoride to the teeth where needed by the dental therapist would be far safer and more effective. Also a lot cheaper.
