Ruapehu is one of New Zealand's largest districts by land area yet has one of the smallest permanent population counts which is made up of many small, diverse and geographically spread out rural communities. It has an area of 6,730 square kilometers and, as at the last census, had a population of 11,844, of which 40% identify as Maori, and 25% are youth and tamariki.

Submission Content

1. Introduction

The Ruapehu District Council (RDC) would like to thank the Department of the Prime Minister and Cabinet for the opportunity to make a submission on the Child and Youth Wellbeing Strategy. RDC believes this will be a fundamental step in building the foundations for a cohesive, nationwide, and government wide approach, giving all children in Aotearoa the best possible start to life and ability flourish.

RDC commends the Government and supports the aspirations and intent of the Child and Youth Wellbeing Strategy.

As part of the submission process, RDC worked with youth groups and advocates across the Ruapehu District. The views this generated are reflected in the submission alongside discussion on the rural and urban divide, the inclusion Te reo Maori and other key languages, and the development of a realisable plan to support the finalised strategy.

2. Comments

2.1 RDC strongly supports the development of a Government strategy to improve child wellbeing in Aotearoa.

2.2 RDC believes that the wellbeing domains, desired outcomes, principles and potential focus areas, contribute to strong foundations upon which to build a brighter future for all our children.

Ruapehu Youth Ambassadors

2.3 Of particular interest to Ruapehu youth ambassadors and the Council is principle seven; 'collective responsibility to nurture the children and young people in our communities, and to support and value the adults who are caring for them'.

2.4 In light of the landscape of challenges that young Ruapehu residents face, and the current climate across the country, the Ruapehu youth ambassadors believe that focus area four regarding "affordable, quality housing" is of particular value.

2.5 RDC would like to recognise the value of focus area four and the acknowledgement of the role of families/whanau in this area.

2.6 Youth ambassadors cited that they need help to feel that they belong, have opportunities to become valuable contributors and have access to tools to support their vocational aspirations which are vitally important. This coupled with RDC's desire to ensure young people in the region have the necessary skills, support and opportunities to keep them on positive pathways means that focus area four' is of additional value to the Ruapehu District.

General Comments

2.7 RDC recognises the significance of focus area eight "the cultures of children, young people and their families and whanau are recognised, enhanced and supported.

2.7.1 In line with this, the Council believes and recommends including a Te reo Maori title and headings in the strategy. Additionally, the Council believes the strategy should be made available in other key languages alongside a Te reo Maori version and an English edition.

2.7.2 The Council would also like to acknowledge four Tikanga based principles which are aligned to the values of the strategy and could be incorporated. These principles are;

- Kotahitanga, united and committed.
- Manaakitanga sharing and caring.
- Whanaungatanga whānau relationships, sharing and cooperation, honesty, respect, quality, openness.
- Mana the capacity to enable equity, integrity and passion to exist and the determination to make a positive sustainable difference.

2.8 Given the low income rural setting of the Ruapehu District, the Council would like to highlight the particular challenges this brings for the districts youth, children and whanau. Healthcare, housing, education, support services and vocational support are often difficult to access.

2.9 The Council commends the government and the courageous step it has taken, in the form of a wellbeing strategy, to acknowledge the needs of the children in Aotearoa. RDC however would like to acknowledge that a strategy will need to be supported by a robust action plan to ensure the strategy and the aspirations it contains come to fruition.

3. Recommendations

3.1 Develop the strategy with a view of how it will translate in to a realisable action plan.

3.3 Develop Te reo Maori title and headings.

3.4 Ensure versions in English, Te reo Maori and other key languages are produced.

3.5 Clearly incorporate the four Tikanga based principles.

3.6 Acknowledge the urban rural divide.

3.7 Give consideration to how the strategy will translate and inform a realisable action plan.

4. Conclusion

RDC thanks you for opportunity to inform the initial Child and Youth Wellbeing Strategy. We look forward to future opportunities to work together on reducing child poverty and improve wellbeing outcomes for all our tamariki.

We hope the proposed strategy will help guide and reinforce the development of the Taumarunui Community Led youth wellbeing framework and future models being developed in the region.
